

PREVENT OR CURE CORRUPTION: YOUR CALL!

Corruption is a negative phenomenon that erodes the value system, undermines the state as a social community and causes material damage to the budget funded by taxpayers.

Therefore, it is highly important that all parts of society actively engage in the fight against corruption and any other form of illegal conduct of public officials and employees, but also other subjects.

All of us, as citizens, have the opportunity to report cases of corruption and illegal conduct to the Administration for Inspection Affairs. Thus, we are helping to establish a system in which law applies equally to everyone, by initiating preventive action by the Administration for Inspection Affairs, or by ensuring, where necessary, a repressive response. By improving the work of the Administration, we can contribute to its professionalisation, and help it to regain the trust of all citizens whose interests it should unreservedly serve.

Administration for Inspection Affairs is one of the mechanisms closest to the citizens in the fight against omnipresent corruption. And we, as conscientious citizens, by our proactive attitude towards the Administration for Inspection Affairs, can significantly help the fight against corruption, already at the "first step".

REPORT IRREGULARITIES TO THE AUTHORIZED INSPECTION!

We need a professional inspection, but also as citizens, we need to show responsibility by reporting any illegal actions that we identify!

YOU IDENTIFIED:

- » Illegal construction, adaptation or upgrading of an object;
- » Work without a contract, non-payment of taxes and contributions, lack of work safety measures;
- » Sale of goods which have expired or have suspicious origin, or you suspect the presence of prohibited substances in food and objects of general use;
- » Tobacco products which do not have prescribed pictorial warnings, prices, discounts, etc on the packaging;
- » Failure to issue fiscal receipts:
- » Discharge of gases from furnaces and other technological outlets that do not meet the conditions prescribed by law, hazardous waste disposal, illegal exploitation of natural resources:
- » Sale of alcoholic beverages and cigarettes to minors;
- » Product which do not match the features or benefits advertised in the offer;
- » Unreported work by tourist guides or facilities, such as renting of private accommodation without authorization by a competent authority;
- » Failure to post and respect the smoking ban sign;
- » Failure to comply with rules on the protection against noise;
- » Offering and soliciting bribe to a health worker, professor, civil servant, state employee, and similar;
- » Issuance of medications without prescription;
- » Destruction of fish by illegal means (dynamite, electricity), usage of fishing gear without authorization;
- » Fishing without license, illegal hunting, unauthorized felling of trees, unregulated production and transport of wood products (timber, boards etc.);
- » Illegal connecting to infrastructure networks (water, electricity, etc.);
- » Setting up gaming machines and joints without authorization, allowing participation of minors in games or wagers;

- » Allocation of public procurement contracts to a bidder who does not meet the requirements of the tender, failure of the contractor to comply with the terms of the contract;
- » Technical malfunction of measuring instruments (water gauge, gauge for discharged quantity of fuel at gas stations, electric meters, taxi meters);
- » and other illegal actions.

Also:

- Inspectors have not acted upon your report?
- > You learned that the inspector has been pressured?
- You have evidence that the inspector received a bribe?
- Inspector has not performed supervision in accordance with the law and did not undertake necessary measures?
- Inspector has for the umpteenth time performed inspection of the same subject, while avoiding others?
- Inspector suggests that you to undertake illegal actions?

In order to help to strength the capacity of inspections, report also these irregularities in the work of inspectors!

Citizens shall be notifed within 8 (eight) days of preliminary or, if possible, final results of the inspection.

You are entitled to feedback - insist on it!




