Dear Mr. President Tusk,

Civil society organisations of the Western Balkans, citizens of our societies, express their hopes and expectations that the European Council will accomplish its promise to set a clear path towards opening the accession negotiations with the Republic of North Macedonia and the Republic of Albania in June 2019, as stated in the Council conclusions on Enlargement and Stabilisation and Association Process, adopted by the Council on 26 June 2018.

We consider good neighbourly relations as one of the key drivers of consolidation of the Western Balkans and its faster integration in the European Union. We highly appreciate the courage and persistence of the leadership of the Republic of North Macedonia and Greece and the pattern of resolving open bilateral issues set by them. We believe that it will be conducive to the settlement of other disputes in the region bringing stability and European future to all of us.

We are afraid that further postponing of the accession negotiations with the two important Western Balkan Countries would seriously affect the pro-European attitude of the population all over the region and could affect the credibility of the European Union. Moreover, it could discourage political elites in the region to resolve other important bilateral disputes.

Two more candidate countries in the Western Balkans would bring a new energy, stability and hope to the region that suffered a decade of conflicts and two decades in confidence building and developing regional cooperation.

We believe in the project of the European Union, expect its internal reforms to make it even stronger and are ready to contribute to make the EU a real home to all the people of Europe.
