Introduction

In 2006, the European Union grouped all support programmes into one comprehensive instrument - the Instrument for Pre-Accession Assistance IPA to provide support to the candidate and potential candidate countries to meet the criteria for membership. Under this programme, Montenegro, but also other countries aspiring to EU membership, receive financial, technical and expert assistance for projects of institutions and other entities to dynamize reforms and improve the living standards of citizens.

One of the smaller, although very visible, beneficiaries of the IPA programme in Montenegro are civil society organisations (CSOs) through the European Instrument for Democracy and Human Rights (EIDHR), the Civil Society Support Instrument (CSF), the Media Professionalization Programme and cross-border programmes (CBC) with Serbia, Albania, Bosnia and Herzegovina, Kosovo, and previously with Croatia, and now trilateral programmes.

This study provides insight into the support to civil society within the above-mentioned instruments from 2012 to 2019, i.e., in the first seven years of negotiations between Montenegro and the EU. To understand the position of civil society concerning the use of IPA funds and the ratio of these funds that are available to them, a review of the financing of projects of ministries from these funds is given as well.

It is important to note that the study does not include an overview of civil society funding in Montenegro from programmes such as *Europe for Citizens, Erasmus +, Creative Europe, Horizon 2020, as well as regional and global EIDHR and IPA programmes,* and service contracts, due to an extremely small number of projects in which Montenegrin organisations are project leaders, although they participate in these as partners¹. It also does not include donations distributed through indirect management of IPA funds managed by the Ministry of Finance of Montenegro, i.e., the Directorate for Financing and Contracting of EU Funds (CFCU), except for cross-border cooperation Montenegro-Albania and Montenegro-Kosovo under IPA II.

European Instrument for Democracy and Human Rights (EIDHR)

The European Instrument for Democracy and Human Rights (EIDHR) represents the European Union's support for the promotion of democracy and human rights in non-EU countries, including the objectives of the Strategic Framework on Human Rights and

Democracy adopted by the EU in June 2012 and the new Action Plan for the period from 2015 to 2019. It is mainly directed through civil society organisations based on open public calls, and these calls are published at the national level by EU delegations, i.e., EC directorates in Brussels when it comes to regional and global calls.

The key objectives of the EIDHR are 1) to support, develop and consolidate democracy in third countries by promoting participatory and representative forms of democracy, strengthening the entire democratic cycle, strengthening the active role of civil society, the rule of law and the credibility of the electoral process, especially through EU election observation missions; and 2) improving respect for human rights and fundamental freedoms, following the UN Universal Declaration of Human Rights and other international and regional human rights instruments, and strengthening their protection, promotion, implementation and monitoring, by supporting relevant civil society organisations, human rights defenders and victims of repression and abuse.

Beneficiaries of the EIDHR in Montenegro are predominantly non-governmental organisations from Montenegro, international organisations and international intergovernmental organisations, as well as their branches in Montenegro. From 2012 to 2019, the Delegation of the European Union to Montenegro distributed 5,301,834.03 EUR to Montenegrin non-governmental organisations, international organisations and their branches, as well as their partners from the countries of the region and the EU. The allocation of funds was done through public calls, except for the allocation of funds to the offices of UNDP and the Council of Europe for two projects in the amount of 1, 435,000 EUR.²


When it comes to the allocation of funds through this programme, in the period 2012-2019 in total, the following organisations received the largest funds for projects as project leaders³:

- 2. Council of Europe 700,000.00 EUR
- 3. Juventas 431,702.62 EUR
- 4. Hilfe zur Selbsthilfe (HELP) 300,000.00 EUR
- 5. Network for Affirmation of the Non-Governmental Sector (MANS) 298,482.00 EUR
- 6. Centre for Civic Education (CCE) 291,403.04 EUR
- 7. SOS Hotline for women and children victims of violence Podgorica 285,000.00 EUR






Overview of the largest lead organisations with supported projects 2012-2019

Overall, the seven organisations that were most successful with their project ideas in withdrawing funds from the EIDHR were represented with 57.37%, while 42.63% were distributed to other organisations. In total, international intergovernmental and non-governmental organisations, as well as their branches in Montenegro, are represented with 38.44%, and Montenegrin non-governmental organisations with 61.56%, i.e. through EIDHR out of 5,301,834.03 EUR with Montenegrin non-governmental organisations, in the last seven years, 3,263,661.12 EUR was directly contracted, while 2,038,172.91 EUR was contracted with international organisations and their branches for activities in Montenegro. This is important to emphasize due to the widespread belief of the general public that funds are allocated only to Montenegrin non-governmental organisations through this programme.

In addition to these seven international organisations/branches and Montenegrin organisations, many others were beneficiaries of EIDHR funds, either as lead or as partners, and details of these projects are given by years in which tenders were conducted and contracts were signed, by project leaders and organisations which directly signed agreements with the EU Delegation to Montenegro.



Civil Society Facility (CSF)


The Civil Society Facility (CSF) was established in 2008 to provide direct financial support to civil society organisations through national, regional and international competitions. It consists of three programme lines: 1) support for national and local civic initiatives and capacity building to strengthen the role of civil society in the region; 2) support for activities carried out in partnership between civil society organisations from the region and EU Member States in order to develop networks and encourage the transfer of knowledge and experience; 3) the "People-2-people" programme, which supports visits to EU institutions and the exchange of experiences, knowledge and good practice between local civil society, the EU and civil society in the Member States⁴.

The goal of the CSF is to support the development of the civil society that actively participates in the public debate on democracy, human rights, social inclusion and the rule of law and can influence the decision-making process.

In many countries, this call is known as the Instrument for Support to Civil Society and the Media, because it includes support for projects of civil society organisations, most often non-governmental organisations, but also organisations dealing with media issues and the media. From 2012 to 2019, EUR 7,870,340.97 was allocated under this programme based on public calls in Montenegro. Among the top seven most successful are Montenegrin NGOs, which withdrew 51% of funding through their projects, while 49% was distributed to others.




Overview of the largest holders of supported projects 2012-2019. years

Of this total amount, international organisations and their branches in Montenegro were supported with 20.93% or 1,647,356.50 EUR, and Montenegrin non-governmental organisations with 79.07% or 6,222,984.47 EUR. In this programme, which is intended for the development of civil society in Montenegro and their ideas in the direction of democratization and Europeanization, a fifth of the funds are allocated to organisations that do not represent part of Montenegrin civil sector.

Media Professionalization Programme

Freedom of expression and free media are some of the preconditions for the functioning of a democratic society. Pluralism in the media, educated and professional staff, but also space for analytical and critical approaches to political processes affect the establishment of a system of good governance in institutions, promoting a culture of tolerance and understanding, as well as improving the overall level of political culture in a candidate country.

The Media Professionalization Programme is part of the Civil Society Facility, which supports the media, NGOs and production companies. The overall goal of this programme is to strengthen participatory democracy and the process of Montenegro's integration into the EU by strengthening and stimulating the professional and financial environment for media pluralism. More specifically, this programme seeks to: 1) strengthen independent and investigative journalism that contributes to quality media production in areas related to Montenegro's path to the EU, 2) support free, professional and ethically based journalism, with a focus on media self-regulation, 3) improve public awareness of misinformation / information impact and media literacy.

The most common priorities of this programme in Montenegro are support for investigative journalism; strengthening professionalism and self-regulation of the media; education and capacity building of media professionals; as well as education of journalists and citizens in the field of media literacy.

From 2016, when this programme functionally started until 2019, through three public calls, 2,072,193.70 EUR was distributed.



Cross-border cooperation


The cross-border cooperation programme aims to promote good neighbourly relations and socio-economic development through joint local and regional initiatives. Given the time frame covered by this study, cross-border projects (CBC) supported through IPA I and IPA II from 2012 to 2019 were covered, namely: Croatia-Montenegro; Montenegro-Albania; Serbia-Montenegro; Kosovo-Montenegro; Bosnia and Herzegovina-Montenegro. Also, a trilateral programme related to joint projects in Montenegro, Bosnia and Herzegovina and Croatia (INTERREG) was discussed.

Under IPA II 2014-2020, Montenegro participates in nine cross-border and transnational programmes⁶:

- three transnational programmes (Adriatic-Ionian, Danube and Mediterranean programmes);
- two trilateral programmes (Croatia-Bosnia and Herzegovina-Montenegro and Italy-Albania-Montenegro);
- four bilateral programmes (Montenegro-Bosnia and Herzegovina, Montenegro-Albania; Montenegro-Kosovo and Montenegro-Serbia).

From 2012 to 2019, Montenegrin local governments, non-governmental organisations, public institutions and institutions received, for their projects, support of 17,551,969.00 EUR.

Of that, the projects of Montenegrin non-governmental organisations were supported with 6,434,030.00 EUR, international organisations and their branches in Montenegro with 553,753.48 EUR, and religious organisations with 701,640.00 EUR. In addition, 9,862,545.51 EUR has been allocated for projects of Montenegrin institutions (local self-governments, ministries and organisational units (institutes), public institutions, etc.).





Contracted funds for projects of Montenegrin institutions (IPA I, IPA II, Western Balkans Investment Framework)

Based on data from the Office for European Integration of the Government of Montenegro, within the financial perspective 2007-2013 (IPA I), the European Commission has allocated a total of 235 million euros for Montenegro for project support to Montenegrin ministries. Besides, over EUR 262 million (EUR 262,600,000.00) has been allocated for IPA II (2014-2020) by 2020.

Within the Western Balkans Investment Framework, including projects within the Berlin Process, about 170 million euros have been committed for Montenegro.




For participation in the programmes of the European Union, the ministries of the Government of Montenegro, together with the Office for European Integration, have at their disposal 13,493,154.00 EUR, while an additional 6,265,000.00 EUR is programmed for the following period.

Based on signed contracts for implemented or still ongoing projects, from 2012 to October 2019, the ministries of the Government of Montenegro effectively withdrew from these three lines over half a billion euros (510,860,985.00 EUR).

- The Ministry of Justice under IPA I and IPA II has implemented or is still implementing projects supported with EUR 28 million. Of this amount, EUR 9,600,000.00 was allocated for activities organized in cooperation with the Ministry of Interior.
- The Ministry of Interior has EUR 65,850,000.00 under IPA I, IPA II and the Western Balkans Investment Framework. Of this amount, EUR 8,350,000.00 are funds received in cooperation with the Ministry of Finance and / or the Ministry of Health for certain projects or programmes.
- The Ministry of Finance has at its disposal 22,600,000.00 EUR which are used independently or in cooperation with other ministries for the implementation of various programmes / projects. Of this amount, 2,500,000.00 EUR are used for joint cooperation with the Ministry of Interior and the Ministry of Economy.
- The Ministry of Education has EUR 13,174,761.00 of EU support for the implementation of approved programmes / projects. Part of these funds is shared with other ministries through certain joint projects, i.e. eight million euros have been allocated for a joint project of the Ministry of Health, the Ministry of Labour and Social Welfare and the Ministry of Education.
- The **Ministry of Science** has so far had **EUR 2,315,784.00** of European Union support for projects approved to them.
- The Ministry of Economy managed to contract EUR 49,148,900.00 of European Union support for its projects. Of that, EUR 3,950,000.00 has been allocated for joint support with the Ministry of Labour, the Ministry of Health, the Ministry of Interior and the Ministry of Finance. An additional EUR 25,000,000.00 has been allocated as part of the Western Balkans Investment Framework.
- The Ministry of Transport and Maritime Affairs has EUR 121,154,239.00 at its disposal. Out of that amount, EUR 2,300.00.00 is allocated for projects that it implements in cooperation with other ministries. An additional EUR 78,400,000.00 was committed from the Western Balkans Investment Framework.
- The Ministry of Agriculture and Rural Development has EUR 27,743,775.00 of support from European funds for its projects.
- The Ministry of Sustainable Development and Tourism has EUR 100,778,903.00 at its disposal from EU funds for approved projects. Of this amount, EUR 24,535,679.00 was allocated for joint

projects with other ministries. Within the Western Balkans Investment Framework, an additional EUR 16,750,000 has been committed.

- The Ministry of Human and Minority Rights has at its disposal a total of EUR 17,235,000.00 of European Union support for its projects.
- Formerly the Ministry of Information Society and Telecommunications, and today the **Ministry of Public Administration** had at their disposal or have **19,050,000.00 EUR**. Of that amount, EUR 15,000,000.00 was allocated for the current project "Budget Support Implementation of the Public Administration Reform Strategy 2016-2020".
- The Ministry of Labour and Social Welfare has EUR 24,916,469.00 at its disposal from EU funds. The signing of the contract for the project "Strengthening the quality and access to health and social services" is currently underway, which brings 8,000,000.00 EUR from the European Union.
- The Ministry of Foreign Affairs had EUR 1,600,000.00 at its disposal for two completed projects.
- The Ministry of Health directly spent EUR 3,800,000.00 on its projects from the European Union. An agreement is currently being signed for an additional EUR 8,000,000.00 of EU support to this Ministry.
- To participate in the institutions of the Government of Montenegro in the programmes and agencies of the European Union, another EUR 13,493,154.00 was available to Montenegro, and an additional EUR 4,815,000 is in the process of programming or signing contracts.

Distribution of European funds to the Government and civil society organisations - for more less, for less more


The European Union has supported civil society organisations with 15,094,368.70 EUR through the European Human Rights Instrument (EIDHR), the Civil Society Facility (CSF) and the Media Professionalization Programme. Of that amount, 3,346,613.55 EUR was directly contracted with foreign organisations or their branches in Montenegro, while 11,747,754.40 EUR was directly contracted with Montenegrin civil society organisations.

Within cross-border programmes (CBC and Interreg CG-BH-HR) from European funds, Montenegrin stakeholders received direct support of 17,551,969.00 EUR, with Montenegrin institutions contracting 9,862,545.51 EUR, Montenegrin NGOs **6,434,030.00 EUR**, international organisations and their branches in Montenegro 553,753.48 EUR, and religious organisations 701,640.00 EUR.

In short, the total amount contracted by Montenegrin NGOs from EIDHR, CSF, MEDIA and cross-border programmes from 2012 to 2019 is **18,181,784.40 EUR**. From the same lines, the institutions contracted 9,862,545.51 EUR (cross-border cooperation), international organisations and their branches in Montenegro 3,900,367.03 EUR (EIDHR, CSF, cross-border cooperation), and religious organisations 701,640.00 EUR (cross-border cooperation).

The largest amount of funds from NGOs, through these four programmes, was received by the Foundation for the Development of the North - FORS Montenegro (1,704,776.00 EUR), followed by the Network for Affirmation of the NGO Sector - MANS (1,400,925.81 EUR), Regional Development Agency for Bjelasica, Komovi and Prokletije (1,383,310.00 EUR), then the Centre for Civic Education - CCE (1,099,806.37 EUR), Center for Protection and Study of Birds - CZIP (973,450.00 EUR), UNDP (966,380.00 EUR), Association for Democratic Prosperity - ZID (806,835), Foundation for Active Citizenship - fAKT (816,999.00 EUR), Center for Monitoring and Research - CEMI (718,445.26 EUR) and the Council of Europe (700,000.00 EUR).

At the same time, the Government of Montenegro and its institutions from the funds directly contracted with the EU 510,860,985.00 EUR with an additional 9,862,545.51 EUR from cross-border cooperation, which is 520,723,530.51 EUR⁹.


When all contracts for civil society organisations (Montenegrin non-governmental organisations, international organisations and their branches, media, production companies, religious communities, trade unions) and the Government and its institutions are included, the data indicate that **95.8% of funds are withdrawn by the Government and its institutions and 4.2% by others**, i.e. 95.8% of governmental institutions, 3.35% of Montenegrin NGOs, 0.72% of international organisations based on public calls¹⁰ and 0.13 religious organisations, i.e. Serbian Orthodox Church.




Percentage relation of allocation of the EU via two categories - CSOs and institutions

Relation of allocation of funds from the European funds expressed in EUR via categories of project holders

As mentioned in the introduction, non-governmental organisations from Montenegro are also beneficiaries of other European funds that are not contracted by the EU Delegation in Montenegro but by the European Commission through the directorates in Brussels and are rarely the lead in these regional or global projects. Among the few, for example, are the Youth Forum and Non-Formal Education - Forum MNE, which for the implementation of the project "Communities first - creating a CSO hub to prevent violent extremism/From prevention to reintegration" in 2018 contracted 910,350.00 EUR through the Multi-country IPA II programme. Within the global EIDHR, in 2015 Juventas received support for the regional project ARYSE of 822,806 EUR, and in 2014 the Youth Initiative for Human Rights from Montenegro, through the same programme, contracted 400,929 EUR for the project "Building free societies without torture and impunity in the Western Balkans". Also, the European Network of Election Monitoring Organisations ENEMO, based in Montenegro and operating in other parts of the world, in 2019 received 212,640.00 EUR for election monitoring in Armenia¹¹.

When looking at the first seven years of Montenegrin negotiations with the European Union and invested funds from the European Union to harmonize Montenegrin society with European standards and best practices, it is clear that the dominant part of these funds is directly contracted with Montenegrin institutions. However, the image that NGOs have unlimited funds with the EU has been created in the public, and this is often accompanied by manipulations and organized campaigns aimed at damaging the reputation of NGOs, especially those who have a critical approach when it comes to public policies and government decisions.

The data presented in the study "European money for the Montenegrin path to the EU" provide a detailed insight into the structure of public calls that support projects of civil society organisations, including most NGOs with significant capacity, with a rough cut of funds contracted by the government and other institutions. Montenegro. These data should serve for a reasoned discussion on how European money is spent on arranging a Montenegrin house, instead of the current practice of a one-sided and selective view of project support from European funds.
