Preparatory activities (if applicable): the activities involved 5 participants

Location / Dates: 5 February 2021, Podgorica (MONTENEGRO)

Short description: Kick off meeting with partners was organized in Podgorica to discuss the planned steps in the implementation of the action. Representatives of all partner organizations (CCE/CGO from Podgorica, Heinrich Böll Stiftung from Berlin/Belgrade, Forum ZfD from Belgrade, Youth Initiative for Human Rights from Zagreb and Association for modern history from Sarajevo) attended the meeting, with the note that part of them attended it directly and part online. At the meeting, a dynamic activity plan was created, project visibility proposals were agreed upon, and an internal financial framework was created, which followed the supported project.

Events:

Event 1 - Traveling exhibition "Ways of coming together and coming apart" (working title) in Belgrade, Sarajevo, Šibenik and Podgorica and production of an Online European Forum in five relevant newspapers/portals in four countries (Croatia, Serbia, Bosnia and Hercegovina, Montenegro)

Location / Dates: The event took place in following cities: **1)** Belgrade (Serbia) from 15 May until 22 May 2021 in Endzio Hub; **2)** Sarajevo, Bosnia and Herzegovina, as part of the international WARM Festival from 12 to 22 July 2021 in Gallery JAVA; **3)** Šibenik (Croatia) from 1 to 4 September 2021 as part of the international FALIŠ Festival at Galley St. Krsevan; **4)** Podgorica (Montenegro) from 22 June to 6 July 2022 at Kuslev House Gallery.

Participation: The event directly involved 211 participants, in following structure: **1)** Belgrade - 50 participants (42 from SERBIA, 4 from MONTENEGRO, and 2 from BOSNIA AND HERZEGOVINA, 2 from CROATIA); **2)** Sarajevo - 40 participants (30 from BOSNIA AND HERZEGOVINA, 2 from MONTENEGRO, 4 from SERBIA, and 4 from CROATIA); **3)** Sibenik - 55 participants (50 from CROATIA, 1 from MONTENEGRO, 3 from SERBIA, 1 from BOSNIA AND HERZEGOVINA); **4)** 66 participants (60 from MONTENEGRO, 1 from BOSNIA AND HERCZEGOVINA, 5 from SERBIA).

Short description: Traveling exhibition "On the Move" started from Belgrade (Serbia), via Sarajevo (Bosnia and Herzegovina) and Sibenik (Croatia) to Podgorica (Montenegro). Through 22 photographs, the exhibition reflected universal human values, the foundations of the European Union, and questioned what remains of these ideas and ideals, as well as how to live if those are insufficient. The photographs pointed out the burning problem of our society: the absence of freedom, particularly the freedom of movement, which directly results in human inequalities, and reveals the tragic absence of empathy and solidarity. A photography exhibition "On the Move" by Damir Šagolj, Igor Čoko, Sandra Vitaljić, and Goran Boričić was set up at the in Belgrade from 15 May until 22 May 2021 in Endzio Hub, a multifunctional space that initiates conversations about civic and relevant topics; in Sarajevo as part of the international WARM Festival dedicated to war, documentary, and socially engaged photography from 6 to 10 July 2021; in Šibenik at the Fališ Festival from 1 to 4 September 2021; and in Podgorica from 22 June 2022 to 6 July 2022 at Kuslev House Gallery, public gallery run by the City Museum and Galleries.

Furthermore, online platform was set up (<u>www.sharedvalues.me</u>) on which, amongst the other material, 40 columns were published from 40 authors from 4 countries (10 per country – Montenegro, Croatia, Bosnia and Herzegovina, Serbia) - https://sharedvalues.me/kolumne. These were also re-publicised by number of media in the region.

Event 2 - Conference on Different Experiences of Totalitarianism and Transition in Germany and Post-Yugoslav Countries "30 years since German unification - where are the post-Yugoslav countries in policy and culture of remembrance?" in Berlin

Participation: The event directly involved 47 participants (3 from BOSNIA AND HERZEGOVINA, 3 from SERBIA, 35 from GERMANY, 3 from CROATIA, and 3 from MONTENEGRO).

Location / Dates: The event took place in Berlin, Germany from 15 to 19 May 2022.

Short description: Heinrich Böll Foundation from Berlin, as project partner, organised the workshop "*Memory Politics in Germany and the Post-Yugoslav Region: Current Debates and Practical Challenges*", which focused sharing experienced on memory politics in Germany and the post-Yugoslavian region. With a view on currents debates and practical challenges, the organisers gathered practitioners and researchers dealing with the remembrance of 'difficult pasts' into dialogue. During this event various approached to dealing with war, flight and expulsion on the one hand, and with the post-socialist past on the other were considered searching for distinctions and connections of the two cases. Also, they discussed the role of the memory of this history in the present, challenges in dealing with history in the public sphere, actors and institutions that are involved and forms of their involvement, etc. Finally, they took museums as starting points to reflect on research discourses and their practical uses and vice versa.

<u>Event 3 - Development</u> of additional teaching material on "EU integration and the process of democratic transition in fractured communities" and national workshops for teachers (Croatia, Serbia, Bosna and Hercegovina,

Montenegro) - training of teachers on the use of materials on the topic "EU integration and the process of democratic transition in fractured communities".

Participation: The event directly involved 125 participants, in following structure: 40 from BOSNIA AND HERZEGOVINA, 25 from SERBIA, 35 from MONTENEGRO, and 25 from CROATIA.

Location / Dates: The event took place on 11 June 2021 in Sarajevo (Bosnia and Herzegovina), 19 June 2021 in Belgrade (Serbia), 19 June 2021 in Podgorica (Montenegro), 7 July 2021 Zagreb (Croatia).

Short description: The project team from BH held a workshop for history teachers at topic "Anti-war movement in Bosnia and Herzegovina in the nineties of the 20th century", and the developed material was piloted through national workshop, held online within the History Fest in Sarajevo. The material for Bosnia and Herzegovina was prepared by Edin Omerčić and is available at the following web address https://sharedvalues.me/nastavni-materijaldzava/3. In Serbia, project team addressed "Anti-war and peace initiatives in Serbia during the wars of the 90s the former Yugoslavia". The developed material was piloted through national workshop, held online by Forum ZfD. The material for Serbia was prepared by Aleksandar Todosijevć and editor Ana Pejovic and is available at the following web address https://sharedvalues.me/nastavni-materijal-dzava/2. Furthermore, in Montenegro project team held a workshop for history teachers at topic "Anti-war and peace initiatives in Montenegro during the wars of the 90s the former Yugoslavia". The developed material was piloted through national workshop, held online by the CCE. The material for Montenegro was prepared by author Igor Radulović and editor Miloš Vukanović and is available at the following web address https://sharedvalues.me/nastavni-materijal-dzava/1. Finally, in Croatia focus of the workshop was "Peace activism in Croatia and the region in the 90s". The developed material was piloted through national workshop, held online by Youth Initiative for Human Right. The material for Croatia was prepared by author dr. sc. Maja Nenadović, editor Nikica Torbica and coordinator Branka Vierda and is available at the following web address https://sharedvalues.me/nastavni-materijal-dzava/4. All workshops included a methodological and contextual introduction, focusing on challenges and importance of teaching this issue, selected set of national sources, as well as individual examples for implementation of class with provided sources. Also, the workshop were attended by teachers from different parts of country, who were keen in expanding these lesson plan by encompassing this topic, particularly as part of 8th-grade elementary education and 4th-grade high school education.

<u>Event 4 - Celebrating</u> the 70th anniversary of the Schuman Declaration by organizing public forums - in Zagreb, Podgorica, Sarajevo and Belgrade and establishment of a web platform - Virtual forum "Integration/Disintegration" **Participation**: The event directly involved 222 participants from different regions of Montenegro, Serbia, Bosnia and Herzegovina and Croatia. Notably 47 in Serbia (45 from SERBIA, 1 from MONTENEGRO and 1 from CROATIA), 70 in Montenegro (67 participants from MONTENEGRO, 1 from BOSNIA AND HERZEGOVINA, 2 from SERBIA), 65 participants in Bosnia and Herzegovina (57 from BOSNIA AND HERZEGOVINA, 2 from SERBIA, 3 from CROATIA, and 3 from MONTENEGRO), and 40 in Croatia (40 from CROATIA).

Location / Dates: The first event took place in Belgrade, Serbia on 15 May 2021, the second one on 31 May 2021 in Podgorica, Montenegro, the third one in Sarajevo, Bosnia and Herzegovina, on 8 June 2021, and the last one in Sibenik, Croatia on 1 September 2021.

Short description: Four panel discussions were organized in four countries. The first two and last one were titled "Different paths – shared values" and organized in Belgrade at Engio Gallery, in Podgorica in the Parliament of Montenegro and in Sibenik, at Gallery St. Krsevan. A round table titled 'European values and Bosnia and Herzegovina: From united Europe, through the disintegration of Yugoslavia to the question 'Where is Bosnia and Herzegovina today?' as part of the History Fest in the Sarajevo City Hall. Panel discussions provided an overview upon the development of the European Union, from Schuman declaration, through internal turbulences and transformations, until today's EU as the unique alliance of countries based on values and standards which support the progress of those countries in every respect. The aim was to emphasized that the dialogue and respect of diversities help the European Union to get out of all crises stronger and that it is necessary to foster healthy social values and work on strengthening and linking progressive capacities. Moreover, public discussions served as a primary tool in dissemination of the project results as they promoted the inclusion of citizens in the debate on the 70th anniversary of the Schuman Declaration where there talked about their growing up in a totalitarian/authoritarian system, their vision of the future of 1990, the experience of transition and today's view of the future, especially related to the EU and its values.

Event 5 - Podgorica Final Conference as an international two-panel public event focusing on the 70th anniversary of the Robert Schuman Declaration and 20 years of the EU Charter of Fundamental Rights – this event was not separately organised but integration within the other activities, which did not influence the set objectives.
